



Republicans Hold Majorities in Both Chambers of Congress

U.S. House 220 Republicans, 212 Democrats, and 3 vacancies (TX-18, AZ-07, and VA-11)

U.S. Senate
53 Republicans, 45 Democrats, and two Independents





Being in the minority means Democrats do not have the power to decide which bills are voted on or debated, or to call hearings.

But that doesn't mean we aren't taking action.

Democracy Under Attack

- President Trump is illegally centralizing power and remaking our democracy into authoritarianism by:
 - Deploying National Guard and Marine troops to squash protests in Los Angeles, over the objections of Governor Newsom and despite First Amendment protections.
 - Detaining and deporting individuals, including at least seven U.S. citizens, sometimes in violation of court orders.
 - Punishing media outlets that publish negative coverage of the Administration.
 - Withholding funds from universities and other institutions that have policies that the Administration disagrees with.
 - Allowing DOGE to make unauthorized spending cuts, illegally fire federal employees, and gain improper access to sensitive data.
 - Pardoning January 6th rioters, including those who assaulted police officers, and other criminals who are politically aligned with the President.
 - Arresting and detaining elected officials, including members of Congress, who are performing their oversight duties.



Fighting the Extreme Trump Agenda in Court

- The Administration has so far issued <u>161 Executive</u> Orders.
- The judicial process is the <u>most effective tool</u> to stop Trump.
- Almost 290 lawsuits have been filed, and at least 184 court orders have been issued blocking or at least temporarily pausing Trump's actions.
- Last month, <u>Trump lost 96%</u> of federal district court cases against his Administration, and had a 78% loss rate in court cases during his first Administration.

Standing Up For America

- House Democrats launched the <u>Litigation and Rapid Response Task Force</u> to fight back against the Trump Administration in court. I have been actively involved in the task force's work, co-chaired by Assistant Democratic Leader Joe Neguse, Congressman Jamie Raskin, and Congresswoman Rosa DeLauro.
- Since the start of the second Trump Administration, <u>I've supported over 140 efforts</u> to stand up and fight back, including:
 - Signing <u>9 Amicus Briefs</u> opposing illegal or unconstitutional actions of the Administration.
 - Sponsoring 10 bills that directly fight against Trump action, including
 - Legislation to prevent the dismantling of the Department of Education.
 - Legislation to stop DOGE's access to sensitive information.
 - Co-signing numerous letters to federal officials along with many of my Democratic colleagues to push back on harmful or illegal actions taken by the Administration.
 - Supporting the state of California's work to hold the Administration accountable through lawsuits challenging the Administration's deployment of the National Guard and the Marines in Los Angeles, the illegal cancellation of California's Clean Air Act waivers, and other harmful policies.
